Chromebook / Chrome Tablet Responsible Use Agreement

I, the Parent/Guardian, understand that I am expected to:

- Ensure my child meets the expectations of the SPS Acceptable Use Policy and Chromebook Handbook, which can be found on the district website,
- Supervise and monitor my child's use (including online) of the Chromebook / Tablet away from school,
- Pay the cost of repairing or replacing the Chromebook, Tablet or Charger should the device be damaged, lost, or stolen if not covered by the SPS Student Technology Insurance Program,
- Return the Chromebook / Tablet and charger when requested or my child withdraws from SPS.

I understand that if my child deliberately damages or through gross negligence, allow damage to or theft of my Chromebook / Tablet, I may be liable for all repairs or replacement of the device. I also understand that my child may be subject to disciplinary action and lose the privilege of using a district issued device.

I, the Student, understand that:

- Use of the Sapulpa Public School Chromebook / Tablet is a privilege,
- I will take care of the Chromebook / Tablet and do my very best to make sure there is no damage and/or drops,
- I must bring the Chromebook / Tablet to the library immediately when repairs are needed,
- I will not loan my Chromebook / Tablet to anyone, not even friends/family,
- I will leave all SPS labeling in place including student name sticker and SPS Asset Tag.
- I must use the Chromebook at school and home (when necessary) in a responsible manner.
- I must tell my teacher or a school employee if there are any problems with my Chromebook / Tablet as soon as possible.
- I must follow the district's policies and rules (including acceptable use policy),
- If I break these rules the consequences may result in disciplinary action,
- I must return the Chromebook / Tablet and charger when requested or when I withdraw from SPS,

If I deliberately damage, or through gross negligence, allow damage or theft to my Chromebook, I may be liable for replacement or repair and/or face disciplinary action up to and including loss of computer use privileges.

Sapulpa Public Schools maintains the right to obtain reimbursement from, or on behalf of, student/parents for any intentional damage to, loss of, or failure to return school property. I understand that the use of district property is a privilege and that it is our responsibility to protect and safeguard the district property and to return the same in good condition and repair upon request by the district.
