We understand that the MCJROTC Program is a regular academic course offered by Sapulpa High School, and **in no way**, is a commitment to nor an enlistment into future military service in the U.S. Armed Forces by your child. Further, it is understood that your child will be required to participate in a physical fitness program, air rifle marksmanship program, and various activities and field trips off the school campus to include United States Government military bases as part of this program.

2. We understand the United States Marine Corps JROTC program recommends that each cadet participating in the MCJROTC Program should be covered by adequate medical insurance at the parent's expense in the event the school does not provide this insurance. The medical insurance should cover any and all injuries either on or off the school campus while participating in a Sapulpa High School MCJROTC program activity.

3. **We understand that our child will be required to wear the Marine Corps dress or field uniform once a week, and wear the physical fitness uniform twice per week.** The wearing of the uniforms constitute a part of the cadet's grade, during each six weeks grading period. Our child will also be graded based on grooming standards, conduct, attitude, and cooperation. This academic course, the largest part of his/her grade, is taught by experienced Marine leaders through time tested methods, and is focused on developing leadership, physical fitness, and good citizenship.

4. **FEDERAL BENEFITS ENTITLEMENT**; Your child, upon successful completion of the MCJROTC Program here at Sapulpa High School, is entitled to an enlisted promotion advancement of pay grade E-2 (and in some cases, promotion to E-3, depending on the military service joined) if they were to join the Armed Services at a later date. Also some colleges (at their discretion) may wavier one year from a college ROTC program, if an individual has successfully completed a high school JROTC program.
